Sale of alcohol will be part of an overall convenience store operation with adequate stock and security measures in place.

b) The prevention of crime and disorder

Adequate CCTV covering the entire premises and immediately outside is installed and will be regularly maintained and equipped with hard drive images to be retained for a minimum of 30 days and to be made available on request to the police and council officials. The DPS to be on the premises during the evenings until close but alcohol may not be sold on the premises in the absence of DPS unless there is another personal licence holder on the premises.

c) Public safety

No risk to public safety including fire hazards has been identified. The premises has emergency lighting and suitable fire extinguishers.

d) The prevention of public nuisance

The applicants will not allow consumption of alcohol purchased on the premises in the vicinity of the premises.

e) The protection of children from harm

A challenge 25 policy shall be maintained with photo ID only accepted. The premises are to maintain a refusals book to be signed off by the DPS weekly.


