### 85. APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillor S Hart, for whom Councillor Johnston was present as substitute, and Mr J Kirby, Kent County Councillor.

## 86. <u>DECLARATIONS OF INTEREST</u>

There were no declarations of interest.

# 87. MINUTES OF PREVIOUS MEETING

The minutes of the meeting of the Board held on 12 December 2012 were approved and signed by the Chairman.

#### 88. MATTERS ARISING FROM PREVIOUS MINUTES

# (a) Zebra Crossing - Northdown Road j/w Godwin Road, Cliftonville

Minute No. 80a refers.

Upon considering the site plan (now published on the website), which had been circulated immediately prior to the meeting, Members expressed concern about the closeness of the proposed zebra crossing to the junction and bus stops. They pointed out that that on previous occasions, requests for crossings, e.g. on Queen's Street, Ramsgate, had been refused on the basis of proximity to junctions.

Paul Valek, District Manager, Kent County Council, Highways & Transportation, said he would refer those comments to the Transportation Engineer, Kent County Council, and report back to the Board.

#### (b) Bridge Works - Seaview Terrace West, Margate

Minute No. 80b refers

Paul Valek, District Manager, Kent County Council, Highways & Transportation, reported that:

- 1. Mike Humber, Engineering & Technical Services Manager, Thanet District Council, had advised that developer funding was still being sought in relation to the toilet block; and
- 2. Upon having recently visited the site, Kent County Council Structures had confirmed that it was safe; they would continue to monitor the situation development took place.

#### 89. HIGHWAY WORKS PROGRAMME 2012/13

Paul Valek, District Manager, Kent County Council, Highways and Transportation, provided further updates as follows:

# Appendix D3 - Developer Funded Works

#### Margate Sea Defence, Margate

Works by Thanet District Council were due to be completed by the end of March 2013

#### The Centre, Newington

Phase 1 – comprising 75% of the scheme – due to be completed by the end of June 2013

Phase 2 – remaining 25% - due to be completed by September 2013

### Westwood, Ramsgate - New Neighbouring Road Network

It was likely that works would be completed by the end of the summer.

Discussion then took place on the following items:

#### **Appendix D3 Developer Funding Works**

#### Ramsgate Road, Broadstairs

Hereson School – new access and zebra crossing on Ramsgate Road and new access to Merrivale Heights serving residential development

#### Members referred to:

1. The fact that developers' traffic was going through Merrivale Heights, which was in contravention of one of the planning conditions agreed by the Thanet District Council Planning Committee;

2. An apparent lack of communication between Kent Highways and Thanet DC Planning Department in relation to Kent Highways' construction works at this location.

A specific inquiry was made as to whether it was proposed to continue the footpath in Merrivale Heights through to the new development.

Paul Valek undertook to refer Members' concerns to Glen Holliday, Agreements Officer, Kent County Council, Highways and Transportation, with a view to ensuring that all parties acted in accordance with the planning agreement. He would report back as soon as possible. He also suggested that a site meeting should take place.

# Appendix C – Street Lighting

It was pointed out by Members that some of the light columns identified in Appendix C as requiring replacement were also included in the list of columns earmarked for a trial switch off, on Appendix A (Annex 1) to the report at agenda item 7 (Minute No. 91 below refers).

John Burr, Director of Highways and Transportation, Kent County Council, Highways & Transportation, confirmed that where it was proposed to switch off lighting on a trial basis, the light columns would not be replaced. The inclusion of the affected columns in Appendix C had been a clerical error.

#### Appendix D3 - Margate Sea Defence

#### Highway works associated with flood defence scheme

Councillor Johnston stated that she understood that there would be some funding left over from the sea defence works which, she suggested, could be put towards the cost of repairing the railings along the seafront. She requested Kent Highways to work in partnership with Thanet District Council with a view to carrying out such repair works.

Paul Valek, who stressed that Kent Highways did not have funding available, said that he would contact Mike Humber, Engineering & Technical Services Manager, Thanet DC about this matter.

# 90. <u>EAST KENT ACCESS ROAD</u>

John Farmer, Major Capital Projects Manager, Kent County Council, Highways and Transportation, presented the report and provided further information as follows:

- 1. Subject to monitoring confirming that the remedial works at Cottington Bridge had been successful, it was proposed to lift up the kerbs and safety barriers, and resurface the uneven area of carriageway in the early summer 2013.
- 2. It was proposed to restrict the 50 mph speed limit zone to about 500 metres on either side of Cottington Bridge in the near future;
- 3. The merging of two lanes of traffic into one, following exit from the Lord of the Manor roundabout onto Canterbury Road East would be reviewed, as would the signage, lane marking and timing of signals at the Lord of the Manor junction roundabout taking account of comments received from the public/Members.
- 4. In the interests of consistency, it was proposed to investigate changing the 50 mph limit to 40 mph on the Canterbury Road West approaches to the residential area of Cliffsend (where there was a 30 mph limit).

Members expressed appreciation for John Farmer's work in relation to the East Kent Access scheme, which, they commented, had brought about significant improvements to traffic flow and calming.

## 91. A COMMON SENSE PLAN FOR SAFE AND SENSIBLE STREET LIGHTING

John Burr, Director of Highways & Transportation, Kent County Council, Highways and Transportation, presented the officers' report, referring to the updated plan (circulated to Members immediately prior to the meeting and now published on the website), which showed three further proposed sites in relation to trial switch off; Eastern and Western Esplanades, Broadstairs and the Marina Esplanade, Ramsgate. These sites were originally to be included in the trial switch off but were removed following a briefing with County Members in advance of the Joint Transportation Board (JTB). Mr Burr confirmed that whilst he was keen that County Members were briefed, he did not intend for the proposals to be amended before the JTB itself.

Specific comments were made by Members as follows:

# 1. Eastern and Western Esplanades

From the point of view of tourism, it was vital that esplanades were lit at night.

# 2. Canterbury Road West

Local residents and Parish Councillors had expressed concern about switching off lights along Canterbury Road West, as there was no proper footway, safety measures had still to be put in place and some cars were reported to travel at 60 mph;

#### 3. Marina Esplanade

There was a CCTV camera in place in this area. Several flats existed and new ones were being built. Residents walked their dogs late in the evenings. There had been recent crime statistics. The developer on site was installing three further cameras.

#### 4. Monkton & Minster

It appeared that neither the Monkton and Minster Parish Councils nor Thanet DC Community Safety Officers had been consulted.

Road proposed for switch off leads to Cummins which employs shift workers. Noted that East Kent Access, in the vicinity, recently completed is not lit.

## 5. Royal Approach Road

The Harbourmaster had advised that he had not been consulted.

There had been incidents of stones being washed onto the road from the sea.

Heavy lorries used this road, and there are pedestrian crossing points present.

There had been reported problems associated with illegal immigrants and drugs.

## 6. Green Lane

Used by night workers, farm workers, lone walkers and some evidence of vehicle breakdowns.

It was proposed by Councillor Johnston, seconded by Councillor H Scobie, that the report be withdrawn to enable Kent Highways to formally consult Monkton and Minster Parish Councils and the Community Safety Partnership.

On being put to the vote, this motion was declared LOST. In response to Members' queries, John Burr and Chris Hatcher (Project Manager) provided the following information:

- a) Turning off every other light along a carriageway was not an option. As the human eye could not cope with repeated changes from darkness to light, it was vital that the level of light remained constant.
- b) Alternative forms of lighting, including LED, had been fully explored. However, in view of their high cost and length of payback period *(minimum of 15 years),* none was found to be financially viable. Kent Highways would, however, continue to seek cost-effective options.
- c) Before introducing part-night lighting, every light column required to be fitted with a light sensitive photo cell and time switch.
- d) Kent Highways had no plans to consult Town and Parish Councils on the trial switch off of lights, as the Joint Transportation Board was considered to be the formal mechanism through which to consult. There will be full consultation on the party night proposals Members were advised that the website is now live and invites feedback on the hours of switch off and the exclusion criteria to be used for selecting the part night sites.
- e) Mr Burr advised that the need to reduce energy consumption through street lighting is KCC Policy.

#### **Recommendation 1 of report**

Each of the sites earmarked for trial switch-off were considered in turn. Mr Burgess advised that the minutes should reflect the strong feeling of the Board and where the vote was close he would not be exercising a casting vote, preferring that the split view of the Board be recorded.

- 2) Part-night lighting; and

#### Recommendation 2 - Exclusion Criteria for part-night lighting

It was AGREED that tourist areas should also be included as an exclusion criterion.

#### Recommendation 3 – Hours of Switch off for part-night lighint

It was AGREED that switch-off time should commence at 1.00 am in the summer.

Mr Burr undertook to inform the Town and Parish Councils of the decisions reached by the Board.

(Councillor Bayford left during this item, before any decisions were taken)

#### 92. TRAFFIC MANAGEMENT - PARKING AND WAITING RESTRICTIONS - THANET

Whilst Members welcomed the proposed parking restrictions in the vicinity of the QEQM Hospital, they recognised that parking problems could be pushed further out as a consequence.

Reference was made to requests from local residents for double yellow lines on Draper's Avenue and Farley Road. Robin Chantrill-Smith, Civil Enforcement Manager, Thanet District Council, said that he would raise those requests at his next meeting with the emergency services.

Members also stressed the importance of enforcement of waiting restrictions.

#### It was AGREED:

- 1. That the recommendations listed in Annex 1 be approved;
- 2. That the proposals which require statutory consultation be advertised and that any objections raised be reported back to a future meeting of the Board.

The Chairman indicated that more feedback would be provided to the Board on these and future traffic management proposals than had been the case in the past.

#### 93. PEDESTRIANISATION TIMES - MARGATE AND RAMSGATE TOWN CENTRES

Suggestions were made by Members, as follows:

a) That bollards be put in place at the top of High Street, Margate to help with enforcement of pedestrianisation, particularly on Sundays.

Paul Valek said he would consult Robin Chantrill-Smith, Civil Enforcement Manager, on this suggestion and respond direct to Councillor M Tomlinson.

b) That traders in High Street, Margate, be fully consulted on the pedestrianisation proposals.

## It was AGREED:

- That the Board supports the officer's recommendations and instructs officers to consult on the proposals to make the operation of the pedestrian areas in Margate and Ramsgate Town Centres common to 10:00 to 17:00 hours every day;
- 2. That the proposals which require statutory consultation are advertised and that any objections are reported back to a future meeting of the Board.

**Summary:** Inform Joint Transportation Boards of the key results of the 2012

Resident, County Member and Parish/Town Council Highway Tracker

Survey. The full survey report is published on the KCC website.

#### Introduction

 Satisfaction surveys, to gauge perception of the highway service have been carried out since 1987. The 2012 survey was undertaken between November and December 2012 and sought views from residents, County Members and Parish/Town Councils.

- An independent market research company called BMG was used to undertake the specialist face to face survey work with residents. All other survey work was undertaken by H&T staff.
- 3. A summary of the results are presented in this report. This information will be used by the Director and Divisional Management team to identify actions to help improve service delivery.
- 4. A total of 1,211 face to face interviews were carried out on a representative sample of Kent residents with approximately 100 interviews in each of the twelve Districts, reflecting the age, gender and economic status.
- 5. In addition to residents views the same survey questions were asked of all County and Parish/Town Councils. A total of 40 County Members responded (a response rate of 48%) and for Parish/Town Councils a total of 152 completed the survey (a response rate of 50%). Response rates are down a little on last year (Member 54% and Parish/Town Council 54%).
- 6. The questionnaire comprised 30 questions, ranging from satisfaction with the condition of roads, pavements, streetlights and local bus and train services through to views on congestion, safety cameras, Member Highway Fund and the Parish Annual Meeting.

## The 2012 survey results

7. To ensure independence in the analysis of the survey results the independent market research company (BMG) was also commissioned to identify key issues emerging from the three stakeholder groups. The

graphs in the following appendix present the results as % satisfied (green line) and % dissatisfied (red line). Results will not add up to 100% as respondents are also offered a neither satisfied or dissatisfied option if they have no strong positive or negative views. Across all stakeholder groups BMG identified the following points;

- a) Only 14% of residents have reported a highway problem in the last 12 months and this is similar to previous years whilst the awareness of the KCC highways 08458 247 800 number has increased from 21% to 39%.
- b) The combined results, when an average is taken from the County Member, Parish/Town Council and Residents groups, suggest that satisfaction with road, pavement and streetlighting has remained broadly the same as last year despite the reduction in maintenance budget.
- c) Similarly for customer service where information has been requested or a problem reported the combined results show a 60% satisfaction level and similar to last year despite the budget pressures on the highway service.
- d) The overall improvement in perception of the service amongst Parish/Town Councils and County Members continues and builds on the benefits of closer liaison with the District Managers and Stewards
- e) Of all road types Country Lanes and Town Centres remains the biggest area of concern across all three groups.
- f) When asked about the top highway priority in their area the top issue for residents was 'repairing roads' (34%), then 'reducing congestion' (21%) then a gap between the next priorities of 'repairing pavements' (10%) and 'reducing speeds' (9%).
- g) Residents who have used the KCC website or Twitter show a 93% satisfaction rating suggesting that those who know of this channel value the information being provided. However awareness of this information is low at 22% and usage of it lower at 5%.
- h) Whilst overall there were 55% of residents who felt that congestion impacts on their journeys to work some hot spots appeared to be Ashford (73%), Tunbridge Wells (67%) and Maidstone (66%). Whilst in Sevenoaks only 32% felt that their working day journeys were adversely affected by congestion.
- i) In relation to public transport 60% of bus users were satisfied with their local services (same as last year) and 68% of train users (up from 67% last year). Those dissatisfied with bus services stated that 'infrequent service' (47%) and 'cost of fares' (35%) as the main reason. For train users the 'cost of fares' (62%) and 'infrequent service' (24%) were the main two areas of concern.
- j) There appears to be more to do around green travel as only 31% consider KCC does enough to support residents in making greener travel choices (36% last year) with 64% stating they have not taken any steps in the last 12 months to travel in a greener way (12% used the bus more and 11% have walked more).
- k) Almost 60% of residents agree that Safety Cameras are helping to make roads safer across Kent and 55% were aware that the cameras are also used to enforce mobile phone and seat belt use.

8. Examples of some of the main results included in the full report are set out in Appendix 1. Figures 1-4 show the combined County Members, Residents and Parish/Town Councils satisfaction results for Roads, Pavements and Streetlights and Satisfaction with Service Received. Figures 5 to 7 set out resident satisfaction results with roads, pavements and streetlights. Figures 8-10 show the results from Parish Councils and Figures 11-13 for County Members.

# **Conclusions from the Director of Highways and Transportation**

- 9. Overall the results show a steady trend when set against the difficult financial position local authorities find themselves in.
- 10. Clearly there is always room for improvement and the Highways and Transportation Division is continuing to develop its service delivery ethos and focus on delivering ever improving outcomes for our ultimate customers, the public of Kent. The contents of this report and the year by year tracking profile it provides continues to be helpful in helping us shape our future actions and improvement plans and as such is greatly valued.




Figure 2 - **Combined Average Results** - Satisfaction with the condition of pavements in the local area – year-on-year comparison (average of residents, County Members & Parish/Town Councils)




Figure 3 - **Combined Average Results** - overall satisfaction with the condition of street lighting in the local area – year-on-year comparison (average of residents, County Members & Parish/Town Councils)




Figure 4 - **Combined Average Results** - overall satisfaction with the service received when asking for information or reporting a problem – year-on-year comparison (average of residents, County Members & Parish/Town Councils)




Figure 5 - **Residents** - Satisfaction with the condition of roads in the local area – year-on-year comparison




Figure 6 - **Residents** - Satisfaction with the condition of pavements in the local area – year-on-year comparison




Figure 7 - **Residents** - overall satisfaction with the condition of street lighting in the local area – year-on-year comparison




Figure 9 - **Parish/Town Councils** - Satisfaction with the condition of pavements in the local area – year-on-year comparison




Figure 10 - **Parish/Town Councils** - overall satisfaction with the condition of street lighting in the local area – year-on-year comparison




Figure 11 **–County Members** - Satisfaction with the condition of roads in the local area – year-on-year comparison




Figure 12 - **County Members** - Satisfaction with the condition of pavements in the local area – year-on-year comparison





Figure 13 - **County Members** - overall satisfaction with the condition of street lighting in the local area – year-on-year comparison



Traffic Management – Changes to Hawley Square and Marine Drive Pay and Display

Summary: To change three sides of Hawley Square on street pay and display

parking to shared residents parking with pay and display and for three pay and display bays along Marine Drive be changed to

disabled and hotel parking.

#### For Recommendation:

## 1. Introduction and Background

- 1.1 Since 2005 the responsibility for parking matters in the Thanet District is spilt between Kent Highways and Transportation for requests relating to safety and Thanet District for amenity requests. Parking Services have carried out a review of these two locations based on requests received from Members, residents and businesses.
- 1.2 The proposal is to change three sides of Hawley Square Margate not including the main road from pay and display only to shared residents parking with pay and display. This would enable Hawley Square to be part of the Margate Addington scheme and allow residents and business to purchase permits which would allow them to park without any restrictions within these bays see appendix 1.
- 1.3 This proposal would also change three bays along Marine Drive from pay and display and allow the new hotel to purchase hotel permits for two allocated bays and give an additional disabled persons parking bay for general use see appendix 2.
- 1.4 Making changes to Traffic Regulation Orders is a lengthy and costly process involving changes to legal documents and thorough public consultation. In order to optimise the handling of these changes, requests are consolidated into categories and amended in bulk. Objections that are received during the public consultation will be brought back to the Board at a future meeting for a decision about whether to abandon, implement or amend the proposed changes.
- 1.5 The officers' recommendations as to whether the proposals should be implemented are based on the General Provision for Traffic Regulation in the Road the Road Traffic Regulation Act 1984. Within the Act changes are considered to be justified:
  - a) to provide more on street parking for residents;
  - b) to provide parking for hotel users;
  - c) to provide parking for disabled persons vehicles;
  - d) to make the road safer for all users.

1.6 Additionally, as a general rule, parking restrictions are not recommended in remote locations where there is little chance of enforcement. This has also given us the opportunity to review the parking restrictions at these locations.

# 2. Options available

- 2.1 Members of the Board can:
- 2.11 Support the officers' recommendations to consult on the proposals,
- 2.12 Recommend amendments to the proposals,

### 3. Corporate Implications

#### 3.1 Financial

- 3.1.1 Parking and waiting restrictions are funded, managed and enforced by the Thanet District Council using the decriminalisation budget.
- 3.1.2 No additional staffing resources are proposed, as these controls are already part of our existing patrols.

## 4.2 Legal

4.2.1 There are no legal implications.

### 5.3 Corporate

5.3.1 The proposals are intended to improve access for resident's and business within the schemes that is in place. If the controls are not introduced, then this would cause continuing displaced parking to the residents of Hawley Square and business within the roads affected.

### 6.4 Equity and Equalities

6.4.1 This proposal will give one additional disabled persons parking bay in Marine Drive and allow residents of Margate Addington to park within additional parking bays.

### 7.0 Recommendation

- 7.1 That subject to the views of this Board, the recommendations shown in appendix 1 and 2 are approved, and
- 7.2 That the proposals which require statutory consultation are advertised, and that any objections are reported back to a future meeting of the Board.


