Do I have a Disclosable Pecuniary Interest and if so what action should I take?

Your Disclosable Pecuniary Interests (DPI) are those interests that are, or should be, listed on your Register of Interest Form.

If you are at a meeting and the subject relating to one of your DPIs is to be discussed, in so far as you are aware of the DPI, you **must** declare the existence **and** explain the nature of the DPI during the declarations of interest agenda item, at the commencement of the item under discussion, or when the interest has become apparent

Once you have declared that you have a DPI (unless you have been granted a dispensation by the Standards Committee or the Monitoring Officer, for which you will have applied to the Monitoring Officer prior to the meeting) you **must**:-

1. Not speak or vote on the matter;
2. Withdraw from the meeting room during the consideration of the matter;
3. Not seek to improperly influence the decision on the matter.

Do I have a significant interest and if so what action should I take?

A significant interest is an interest (other than a DPI or an interest in an Authority Function) which:

1. Affects the financial position of yourself and/or an associated person; or
Relates to the determination of your application for any approval, consent, licence, permission or registration made by, or on your behalf of, you and/or an associated person;
2. And which, in either case, a member of the public with knowledge of the relevant facts would reasonably regard as being so significant that it is likely to prejudice your judgment of the public interest.

An associated person is defined as:

- A family member or any other person with whom you have a close association, including your spouse, civil partner, or somebody with whom you are living as a husband or wife, or as if you are civil partners; or
- Any person or body who employs or has appointed such persons, any firm in which they are a partner, or any company of which they are directors; or
- Any person or body in whom such persons have a beneficial interest in a class of securities exceeding the nominal value of £25,000;
- Any body of which you are in a position of general control or management and to which you are appointed or nominated by the Authority; or
- any body in respect of which you are in a position of general control or management and which:
 - exercises functions of a public nature; or
 - is directed to charitable purposes; or
 - has as its principal purpose or one of its principal purposes the influence of public opinion or policy (including any political party or trade union)

An Authority Function is defined as: -

- Housing - where you are a tenant of the Council provided that those functions do not relate particularly to your tenancy or lease; or
- Any allowance, payment or indemnity given to members of the Council;
- Any ceremonial honour given to members of the Council
- Setting the Council Tax or a precept under the Local Government Finance Act 1992

If you are at a meeting and you think that you have a significant interest then you **must** declare the existence **and** nature of the significant interest at the commencement of the matter, or when the interest has become apparent, or the declarations of interest agenda item.

Once you have declared that you have a significant interest (unless you have been granted a dispensation by the Standards Committee or the Monitoring Officer, for which you will have applied to the Monitoring Officer prior to the meeting) you **must:-**

1. Not speak or vote (unless the public have speaking rights, or you are present to make representations, answer questions or to give evidence relating to the business being discussed in which case you can speak only)
2. Withdraw from the meeting during consideration of the matter or immediately after speaking.
3. Not seek to improperly influence the decision.

Gifts, Benefits and Hospitality

Councillors must declare at meetings any gift, benefit or hospitality with an estimated value (or cumulative value if a series of gifts etc.) of £25 or more. You **must**, at the commencement of the meeting or when the interest becomes apparent, disclose the existence and nature of the gift, benefit or hospitality, the identity of the donor and how the business under consideration relates to that person or body. However you can stay in the meeting unless it constitutes a significant interest, in which case it should be declared as outlined above.

Executive Summary:

The Council is required to undertake a review of its Parliamentary polling districts and polling places between 1 October 2018 and 31 January 2020. The review formally commenced on 29 July and a public consultation was undertaken where the public and interested parties were invited to make submissions, the consultation opened on Monday 2 September and ran until 5pm on Friday 11 October. Comments and alternative proposals for polling stations in BSB Beacon Road ward and BSH Viking Ward were received. The report outlines the responses to these suggestions and asks the Boundary and Electoral Arrangements Working Party to recommend the proposals as set out at Annex 2 to the report to Council.

Recommendation(s):

The recommendation from the Boundary and Electoral Arrangements Working Party:

“That, subject a re-assessment of Piermont Hall as soon as practicable, the proposals for polling districts, places and stations for future elections, as attached at Annex 2 to the report, be recommended to Council.”

Financial and Value for Money	The financial implications are contained within the body of the report however, it is worth noting that the cost of the temporary solution identified at 5.2.4 is excessive and will likely not be recoverable, as a result budget would need to be identified if an option other than that proposed as per the attached were selected.

1.0 Introduction and Background

1.1 This paper reports the outcome of the consultation carried out in respect of the Polling District and Polling Place Review and asks Council to approve a schedule of Polling Districts and Polling Places.

2.0 Background to the Review

2.1 The Council is required to undertake a review of its Parliamentary polling districts and polling places between 1 October 2018 and 31 January 2020.

2.2 When undertaking a review the authority must:

- seek to ensure that all electors in a constituency in its area have such reasonable facilities for voting as are practicable in the circumstances;
- seek to ensure that so far as is reasonable and practicable every Polling Place for which it is responsible is accessible to electors who are disabled;

- have regard to the accessibility of disabled persons of potential Polling Stations in any place which it is considering designating as a Polling Place or the designation of which as a Polling Place it is reviewing;
- ensure that the Polling Place for a Polling District must be in an area in the district, unless special circumstances make it desirable to designate an area wholly or partly outside the district;
- consider that the Polling Place for a Polling District must be small enough to indicate to electors in different parts of the district how they will be able to reach the Polling Station.

3.0 The Review

3.1 All existing polling stations were evaluated by Officers at both the European Parliamentary and the District and Parish Elections using the evaluation checklist used by the Electoral Commission. Upon completion, Officers analysed each individual polling station checklist to ascertain the suitability of the existing polling stations.

3.2 In addition where Democratic Services felt they had insufficient details as a result of the checklist above, further visits were undertaken by officers. All of the collated information was then used to create the proposals to be consulted upon.

4.0 Consultation

4.1 A public consultation was undertaken with the public and interested parties were invited to make submissions. The consultation opened on Monday 2 September and ran until 5pm on Friday 11 October. The following stakeholders were invited to make submissions:

- All 56 Members of Thanet District Council.
- The seven Kent County Councillors for the Thanet District.
- The two MPs covering the Thanet District.
- The 11 Parish Council's covering the Thanet District.
- Disability Groups, including the Kent Disability Forum, the Disability Drop in Centre, Kent Rise 4 Disability, Kent Association for the Blind, Age UK Thanet and Ageless Thanet.
- The local Conservative, Labour, Liberal Democrats, Green, UKIP and Thanet Independents political parties.
- Residents Associations
- All current polling stations
- Thanet Police
- Canterbury City Council, Dover District Council and Kent County Council.

4.2 The consultation was also advertised on the Council's website and through its social media channels and was also covered in the local press and on regional television news. A schedule of current Polling Districts and Polling Places with the proposed amendments by the Returning Officer was made available to all parties who were consulted and a map outlining the location of the polling districts and places together with the polling stations used at the May 2019 local elections was available on the Council's dedicated polling review webpages. In addition, Democratic Services also designed a google form to make responding to the consultation easier and this was also available on the Council's dedicated review webpage.

4.3 Democratic Services received 20 responses in total and these are summarised at Annex 1 to the report.

5.0 Themes within the responses

5.1 There were no comments suggesting alternative polling Districts. There were positive comments regarding a number of polling stations and it is not felt that these comments require any formal recommendations. Of the 20 responses nine were critical of the choice of using St Andrews Church for the polling station for polling district BSB and have suggested a variety of alternatives. A further three were received that were critical of the choice of Queens Road Baptist Church in polling district BSH and have suggested an alternative venue.

5.2 BSB, Beacon Road - St Andrews Church Hall, Reading Street, Broadstairs

5.2.1 The nine submissions received criticising the choice can be summarised as follows:

- Lack of parking facilities in the area.
- Discriminates against those without a car.
- Difficult to get to for elderly or disabled voters.
- Inappropriate as a double station.
- Poor internal lighting.
- Confusing layout of the polling station.

5.2.2 After further discussions and investigations by the Electoral Services Team we can make the following responses to the points raised:

- It is acknowledged that the polling station does not have a dedicated car park, however that is the case for many stations. There is an ample amount of parking on the surrounding streets, as confirmed by the Parish administrator.
- The hall used for this polling station is large and more than adequate for use as a double station. At its last inspection it was also found to have satisfactory lighting.
- The new station is only 175 metres from the edge of the polling district and approximately 550 metres from the middle of the St Peters estate. This is not considered to be an excessive distance for people to travel. Alternatives to physically attending the polling station are also available in the form of postal or proxy votes.

5.2.3 The following places were proposed as alternatives :

- Use of St Peters House
- Use of the Cabin Cafe
- Requisition of the former Westover Free Church building
- Use of a temporary polling station somewhere on the St Peters estate

5.2.4 After further discussions and investigations by the Electoral Services Team we can make the following responses to the suggestions made:

- St Peters House has been contacted via Kent County Council about the possibility of using part of it as a polling venue. To date the Electoral Services team have had no response from St Peters House.
- Electoral Services have contacted the owners of the Cabin Cafe and they have confirmed that they are not willing to allow the use of their building as a polling station.

- Requisition of the former Westover Free Church is not possible, as the building is currently in a condition that makes its use as a polling station unsuitable.
- Democratic Services have investigated and compiled a total estimated cost of siting a temporary polling station on Westover Gardens. The cost would be £3800 per election. This consists of Portakabin hire, ramp hire, delivery fees, generator hire, toilet hire and health and safety equipment hire. A number of submissions have stated that electoral costs are reclaimed from a national pot. This is correct for nationally run elections i.e. Parliamentary, however it is not the case for local elections, where the relevant local authority that candidates are being elected to pays. As a result those authorities are entitled to query unnecessary expenditure, including the costs of polling stations. To give further context the total spend on polling stations for the 2019 European elections was £12,061.50. Spending an additional £3800 on polling stations will increase the risk of other authorities declining to pay for what they see as unreasonable costs.

5.2.5 In addition to the points discussed above, Democratic Services have also undertaken searches for alternatives to the Westover Free Church station. These have included conversations with both Cherry Court residential home and local shops. None of these would be suitable as polling stations. Democratic Services have also considered and undertaken a visit to the Scout Hut in the grounds of Callis Grange School. However the school refused permission and so the building cannot be used..

5.2.6 Conclusion Regarding BSB, Beacon Road - St Andrews Church Hall, Reading Street, Broadstairs

To retain use of the St Andrews Church Hall, Reading Street as the polling station for the BSB polling district.

5.3 BSH, Viking - Queens Road Baptist Church, Queens Road, Broadstairs

5.3.1 The three submissions received criticising the choice can be summarised as follows:

- Poor access for car users and lack of parking.
- Insufficient number of polling stations in the polling district.
- Not located centrally.
- Facilities won't be as good as the new Pierremont Hall offices.
- The Baptist Church is not the civic hub of the town.

5.3.2 After further discussions and investigations by the Electoral Services Team we can make the following responses to the point raised:

- Whilst it is correct that there is no parking outside of the polling station, there are car parking spaces running the length of Broadstairs High Street which is immediately adjacent to the station. In addition Crofts Place is a 63 space pay and display car park less than 100 metres from the station.
- The number of polling stations within a polling district is determined by the number of electors within the polling district; a polling station should not accommodate more than 3000 electors. BSH currently has 2960 electors of which 513 are absent voters, thereby making the ratio of polling stations within the ward correct. There is therefore no need for additional polling stations in the polling district.

- The polling station is more centrally located within the polling district than the previous station at Pierremont Hall, which is in the extreme corner of the polling district.
- It is difficult to judge the facilities at this polling station against those at Pierremont Hall, as at the time of writing Pierremont Hall is closed and still under renovation and so not available.
- Whether a polling station is considered a civic hub is not a relevant consideration.

5.3.3 The following were proposed as alternatives:

- Pierremont Hall

5.3.4 After further discussions and investigations by the Electoral Services Team we can make the following response to the suggestion made:

- At the time of writing Pierremont Hall is closed and still under renovation and so not available to be used as a polling station. However this would not preclude from future use once it is open, subject to inspection, and this may result in a change being made in the future.

5.5.3 Conclusion regarding BSH, Viking - Queens Road Baptist Church, Queens Road, Broadstairs

To retain use of the Queens Hall Baptist church, Queens Road, Broadstairs as the polling place and station for the BSH polling district. In addition, to review Pierremont Hall once all works have been completed.

6.0 The rest of the review

6.1 There were a number of other changes proposed as part of the review. These included the change of both polling stations in the Salmestone ward. There were no responses to the public consultation regarding these changes. A full list of all of the proposed polling places and stations is available at Annex 2 to the report.

7.0 Consideration by the Boundary and Electoral Arrangements Working Party

7.1 The Boundary and Electoral Arrangements Working Party considered this report at its meeting on the 18 December 2019. The Working Party reviewed the proposed list of polling stations and made the following recommendation to Council:

“The Working Party agreed that, subject a re-assessment of Piermont Hall as soon as practicable, the proposals for polling districts, places and stations for future elections, as attached at Annex 2 to the report, be recommended to Council.”

8.0 Options

8.1 There are 3 options available to Council:

Option 1

8.1.1 To accept the recommendation from the Boundary and Electoral Arrangements Working Party:
