#### Do I have a Disclosable Pecuniary Interest and if so what action should I take?

Your Disclosable Pecuniary Interests (DPI) are those interests that are, or should be, listed on your Register of Interest Form.

If you are at a meeting and the subject relating to one of your DPIs is to be discussed, in so far as you are aware of the DPI, you **must** declare the existence **and** explain the nature of the DPI during the declarations of interest agenda item, at the commencement of the item under discussion, or when the interest has become apparent

Once you have declared that you have a DPI (unless you have been granted a dispensation by the Standards Committee or the Monitoring Officer, for which you will have applied to the Monitoring Officer prior to the meeting) you **must:-**

- 1. Not speak or vote on the matter;
- 2. Withdraw from the meeting room during the consideration of the matter;
- 3. Not seek to improperly influence the decision on the matter.

#### Do I have a significant interest and if so what action should I take?

A significant interest is an interest (other than a DPI or an interest in an Authority Function) which:

- 1. Affects the financial position of yourself and/or an associated person; or Relates to the determination of your application for any approval, consent, licence, permission or registration made by, or on your behalf of, you and/or an associated person;
- 2. And which, in either case, a member of the public with knowledge of the relevant facts would reasonably regard as being so significant that it is likely to prejudice your judgment of the public interest.

An associated person is defined as:

- A family member or any other person with whom you have a close association, including your spouse, civil partner, or somebody with whom you are living as a husband or wife, or as if you are civil partners; or
- Any person or body who employs or has appointed such persons, any firm in which they are a partner, or any company of which they are directors; or
- Any person or body in whom such persons have a beneficial interest in a class of securities exceeding the nominal value of £25,000;
- Any body of which you are in a position of general control or management and to which you are appointed or nominated by the Authority; or
- any body in respect of which you are in a position of general control or management and which:
   exercises functions of a public nature; or
  - is directed to charitable purposes; or
  - has as its principal purpose or one of its principal purposes the influence of public opinion or policy (including any political party or trade union)

An Authority Function is defined as: -

- Housing where you are a tenant of the Council provided that those functions do not relate particularly to your tenancy or lease; or
- Any allowance, payment or indemnity given to members of the Council;
- Any ceremonial honour given to members of the Council
- Setting the Council Tax or a precept under the Local Government Finance Act 1992

If you are at a meeting and you think that you have a significant interest then you <u>must</u> declare the existence **and** nature of the significant interest at the commencement of the matter, or when the interest has become apparent, or the declarations of interest agenda item.

Once you have declared that you have a significant interest (unless you have been granted a dispensation by the Standards Committee or the Monitoring Officer, for which you will have applied to the Monitoring Officer prior to the meeting) you **must:-**

- Not speak or vote (unless the public have speaking rights, or you are present to make representations, answer questions or to give evidence relating to the business being discussed in which case you can speak only)
- 2. Withdraw from the meeting during consideration of the matter or immediately after speaking.
- 3. Not seek to improperly influence the decision.

#### Gifts, Benefits and Hospitality

Councillors must declare at meetings any gift, benefit or hospitality with an estimated value (or cumulative value if a series of gifts etc.) of £25 or more. You **must**, at the commencement of the meeting or when the interest becomes apparent, disclose the existence and nature of the gift, benefit or hospitality, the identity of the donor and how the business under consideration relates to that person or body. However you can stay in the meeting unless it constitutes a significant interest, in which case it should be declared as outlined above.

If you are in any doubt, Members are strongly advised to seek advice from the Monitoring Officer or the Committee Services Manager well in advance of the meeting.

# Minutes of the meeting held on 22 March 2022 at 7.00 pm in Council Chamber, Council Offices, Cecil Street, Margate, Kent.

#### 1. <u>APOLOGIES FOR ABSENCE</u>

Apologies were received from Councillors Binks and Lewis.

#### 2. DECLARATIONS OF INTEREST

There were no declarations of interest.

#### 3. MINUTES OF PREVIOUS MEETING

Councillor Crow-Brown proposed, Councillor Scobie seconded and Members agreed that the minutes be approved as a correct record of the meeting held on 14 December 2021.

#### 4. HIGHWAYS FORWARD WORKS PROGRAMME: 2021/22 AND 2022/23

The following questions were received in relation to the report; the relevant Kent County Council Officer would respond following the meeting.

Councillor Crow-Brown asked the following question on behalf of Councillor Binks who could not be present at the meeting:

Did Thanet District Council (TDC) clean public rights of way? Could Councillor Binks have a list of public rights of way that were not cleaned by TDC?

Councillor Yates asked if there were plans to change the traffic flow following the reconstruction work to the footway at New Cross Street.

Members noted the report.

#### 5. TRAFFIC MANAGEMENT ACT UPDATE

Ms Button, Director of Neighbourhoods, TDC, provided the Board with a brief summary of the changes to the Traffic Management Act that would come into force on 31 May 2022. During the update it was noted that:

- The Off Street Traffic Order will be consolidated under the new act
- The guidance indicated that not every sign would be enforced; it was intended that the Act be used to target problem areas.
- TDC would highlight problem areas to KCC and KCC would decide where to take action. If Members knew of any problem areas they could advise Ms Button in the first instance.
- The consolidation of the traffic orders should make things more simple for TDC going forward.

#### 6. <u>TDC STRATEGY AROUND THE SIZE AND ENFORCEMENT OF DISABILITY</u> <u>PARKING BAYS</u>

Mr Wraight, a resident with a disabled parking bay, advised the Board of the problems that he had been facing. He had experienced vehicles, which did not have a blue badge, parking partly in the bay and this stopped him from being able to use it. His interactions with TDC had been unsuccessful in resolving the issue and the information he had been given by Officers appeared contradictory and inconsistent. He had also found it difficult to report incidents, particularly during out of hours periods.

Councillor Whitehead spoke under Council procedure 20.1. She reiterated the problems faced by Mr Wraight, and noted that she felt that TDC was failing in its public sector equality duty. She wished for the issues to be addressed and for Council to receive an update on progress towards personalised disabled bays.

Ms Young, Parking Policy Officer, TDC introduced the report that summarised the process and detailed what actions were within TDC's power. During the presentation the following points were noted:

- The application process explained clearly that the bays could be used by anyone with a valid blue badge.
- There were some historic bays that were smaller than the recommended size in current guidance. An audit was underway to identify these bays and some extensions had already been made.
- Enforcement was conducted by TDC's Enforcement Officers, they patrolled an area during their shift, and certain areas were prioritised.
- Reports of illegal parking could be made outside of standard working hours and problem areas could be incorporated into patrols.
- In order to issue a ticket, the Enforcement Officer must witness the offence first hand.

The following points were noted during the consideration of the report by the Board:

- Ms Button offered to look at the out of hours contact to see if any improvements could be made, however she noted that TDC did not and could not offer an out of hours enforcement service where officers would attend immediately following the report of an incident.
- Ms Button would investigate the suggestion that a vehicle needed to be illegally parked with at least 50% of the vehicle in the bay in order to receive a ticket.
- Photographic evidence was not sufficient to enable TDC to issue a ticket; legislation required the Enforcement Officer to see the offence and place the ticket on the vehicle.
- There was no limit on the number of disabled bays within the District.
- Residents could email <u>car.parking@thanet.gov.uk</u> to record an incident.
- Mr Wraight would meet with Officers to discuss his concerns.

Members noted the report.

#### 7. PROPOSED WAITING RESTRICTIONS - VARIOUS ROADS THANET

Ms Young introduced the report that detailed requests to install 'No Waiting' restrictions in various locations across Thanet.

Councillor Fellows proposed, Councillor Crow-Brown seconded and Members agreed that:

"The recommendations shown in appendix 1 are approved and that the proposals which require statutory consultation are advertised, and that any traffic related objections are reported back to a future meeting of the Board."

#### 8. PROPOSED DISABLED PERSONS PARKING PLACES - VARIOUS ROADS THANET

Ms Young introduced the report that detailed the locations of 19 interim bays. A small consultation had taken place with the direct neighbours for each of the bays and TDC now looked to begin the next step of the process, formal public consultation, with the intention of eventually making the bays enforceable.

Councillor Shonk proposed, Councillor Yates seconded and Members agreed:

"To recommend option 1 - that the parking places for disabled person's vehicles as listed in annex 1 would be exposed for formal public consultation.

That the proposals which require statutory consultation are advertised, and that any traffic related objections are reported back to a future meeting of the Board."

#### 9. VERBAL UPDATE ON PUBLIC CONSULTATIONS

Ms Young offered the Board an update on the proposed restrictions that had previously come before the Board and had then gone to public consultation. During the update it was noted that:

- Off-street parking for caravans and motor-caravans:
  - Following a recommendation from the Board, consultation took place regarding off-street parking for caravans and motor caravans.
  - One comment was received, and it was in favour of the proposals.
  - The costs were agreed by Full Council in the Fees and Charges 2022-23 report, and it was anticipated that it would go live on 1 April 2022.
  - The locations for caravan and motor-caravan parking would be:
    - Five bays in Minnis Bay, Birchington
    - Four bays in St Mildreds Bay, Westgate
    - Five bays in Barnes Car Park, Margate
    - Three bays in Joss Bay, Broadstairs
    - Four bays in Marina Esplanade, Ramsgate
  - There would be a £10 charge for 24 hours of parking.
  - Users could pay via RingGo or the pay and display machines, depending on the location.
- The on-street consolidation order:
  - This related to the installation of a number of double yellow lines within the District, and a 'No Loading' ban in Herbert Place, Margate.
  - There were multiple responses from businesses raising concern about the Herbert Place proposal. Therefore the proposal would be amended to allow space for a goods vehicle loading bay. The amended proposal would now be consulted upon.
  - There were multiple objections to the proposal to extend the existing double yellow lines in Edgar Road, Cliftonville. In

response to this concern, the double yellow lines would remain unchanged.

- All the other double yellow line proposals within the order would go ahead as proposed.
- Ms Young offered to look into cases of parking on the double yellow lines on Grange Road, Ramsgate.

Summary:	This report provides information on a proposed Casualty Reduction Scheme in Northdown Road, Margate prior to public consultation.

#### For Information

#### **1.0 The Proposed Scheme**

- 1.1 Kent County Council KCC) is proposing to make some changes to Northdown Road to reduce the number of personal injuries occurring particularly to pedestrians through road traffic collisions.
- 1.2 During the past ten years, up until March 2021, there were 49 collisions reported to the police where a pedestrian was injured. We have already made improvements for pedestrian safety along Northdown Road during this time, but the collision rate remains high. A recent study of the road and previous crashes along it identified the following issues:
  - The footpath on the southern side of the road is in shade for much of the day, making any pedestrians waiting to cross less visible to drivers.
  - The road is straight, which may encourage drivers to travel at a higher speed.
  - Some pedestrian crossing points are in front of bus stops, so drivers passing a bus at the stop may not see a pedestrian stepping out until they are out in the road.
  - There are many pedestrian crossing points (informal dropped kerbs and zebra crossings), often very close together.
  - Two of the zebra crossings incorporate centre islands, and some crashes seemed to have occurred when a pedestrian has crossed to the centre island, and then been struck on the second part of the crossing. There may be uncertainty between pedestrians and drivers whether to treat such crossings as one or two separate movements.
- 1.3 In response to these concerns, we are proposing the following changes in eight locations along Northdown Road:
  - Location 1 and 2 On Clifton Road and St Paul's Road: Reduction of 'at any time' waiting restrictions (double yellow lines)
  - Location 3 By Arthur Road: The existing parking bays (equivalent to four car lengths) would be reduced to the equivalent of three car lengths and moved near to the junction of Arthur Road. The footway would be widened to allow buses to pull up close to and parallel to the kerb. This will also allow

pedestrians crossing outside of the church to see vehicles approaching from their right.

On Wilderness Hill: The existing parking bay extended by the equivalent of one and a half car lengths. The 'give way' line would be moved forward to give better visibility for drivers turning out of the junction.

• Location 4 - By Wilderness Hill: The existing bay would be extended by approximately one car length. A new footway build-out would be created on the southern side along with dropped kerbs for pedestrian crossing points on both sides. The kerbs at the bus stop will also be raised.

By Edgar Road: The footway would be enlarged in front of St Paul's Church and a pedestrian crossing point created set back into the side road. The existing splitter island would be removed and narrowed at its junction with Northdown Road. The footway on southern side of road would be widened on both sides of the zebra crossing. The existing centre islands would be removed from the zebra crossing as well as the existing parking bays on the north side to allow the full eight zig-zag marks for the zebra crossing to be placed. By shortening the width of the crossing, we would improve visibility between pedestrians waiting to cross and approaching vehicles.

- Location 5 Northdown Road: The dropped kerbs would be replaced with raised bus stop kerbs and the existing pedestrian crossing point removed. The build-out on north side would be removed with full height kerbs reinstated and a smaller island installed with a 'keep right' bollard.
- Location 6 By Sweyn Road: We are not proposing any changes to the existing zebra crossing. However, we would extend the wider part of the footway southwards to discourage drivers from stopping and blocking visibility for pedestrians. It will be necessary to relocate the carriageway gully.

By Godwin Road: The dropped kerbs would be replaced with raised bus stop kerbs and the footway build-out would be reduced to allow the extension of a parking bay by the equivalent of one car length.

• Location 7 - Northdown Road: The build-out footway would be removed, and parking bays joined to allow the equivalent of one additional car length. The dropped kerbs would be replaced with raised bus stop kerbs.

By Prices Avenue and Harold Road: The existing pedestrian guard railing would be extended by two 2 metre lengths.

• Location 8 - By Lyndhurst Avenue and Warwick Road: The existing centre islands would be removed from the zebra crossing. The southern side footway would be further widened. The Lyndhurst Avenue junction line would be moved out, in line with widened southern footway.

1.4 The scheme would deliver positive impacts by:

- improving road safety for all road users
- improving facilities for bus users
- increasing parking provision in the area
- 1.5 The scheme is being funded by KCC's Crash Remedial Measures fund.
- 1.6 An Equality Impact Assessment (EqIA) will be undertaken to assess possible impacts of the scheme on protected characteristics as defined in the Equality Act 2010. These

are: age, disability, sex, gender identity, sexual orientation, race, religion, and carer's responsibilities.

- 1.7 During the works, alternative routes would be provided for pedestrians with barriers and ramps for those with visual and mobility impairments, as required and in accordance with industry standards.
- 1.8 A public consultation is currently being put together and residents and businesses will be letter-dropped, public notices will be placed on site and posts will be put on internet and social media platforms.
- 1.9 The results of the consultation will be used to help finalise the scheme design and the results will be reported to this Joint Transportation Board.

Summary: This report updates Members on the identified schemes approved for construction

#### 1. Introduction\_

This report provides an update and summarises schemes that have been programmed for delivery in 2021/22 and 2022/23.

Kent County Council has recently published a forward works programme for the next five years covering planned maintenance of our highway assets. It is in two parts: the first concerns the next two years (2021/22 - 2022/23), and most of the sites included have already been verified by our engineers. The second part relates to years three to five of our five-year programme (2023/24 - 2025/26) and is largely based on data from our asset management systems, so may be subject to more changes as the schemes are verified.

This programme is subject to regular review and may change for a number of reasons including budget allocation, contract rate changes, and to reflect our changing priorities. The programme and extent of individual sites within the programme may also be revised following engineering assessment during the design phase, and additional sites may be added or others advanced if their condition deteriorates rapidly so that we need to react in order to keep the highway in a safe and serviceable condition.

### For Recommendation

### **1.0 Introduction and Background**

- 1.1 Kent County Council (KCC) is proposing the installation of 'at any time' waiting restrictions (double yellow lines) within the District in the interests of highway safety and for facilitating the movement of traffic.
- 1.2 The proposed locations and reasons are as follows:
  - Arthur Road, Minnis Bay To prevent obstructive parking across Viking Close, especially during peak summer season.
  - Greystones Way junction with Foads Hill, Cliffsend to prevent obstructive parking on corners of junction.
  - Royal Esplanade, Ramsgate To prevent parking across pedestrian dropped kerbs.
  - Victoria Parade, Ramsgate to improve sightlines of cyclists using cycle route, where they come off the promenade onto the road.

Plans of the proposals are attached in Appendix A.

- 1.3 The proposals were advertised on Friday 8 April 2022. Notices were placed on site and the closing date for comments and objections was 12 noon on 2 May 2022.
- 1.4 As a result of the statutory consultation, 19 comments were received. 14 in support and six against.

### 2.1 **Results of Consultation**

2.1 The objections raised in the comments can be summarised as follows (some responses included more than one comment):

### Proposed 30mph Speed Limit – Nash Road, Margate

### For Recommendation

### **1.0 Introduction and Background**

- 1.1 As part of the residential developments taking place near Westwood Cross, Broadstairs, part of Nash Road was realigned to provide a safe access and egress point.
- 1.2 It is proposed to reduce the speed limit on this section of road to 30mph to further enhance safety for vehicles using the junction. The Traffic Regulation Order is being funded by a third party.
- 1.3 A plan of the proposal is attached in Appendix A.
- 1.4 The proposals were advertised on Friday 19 November 2021. Notices were placed on site and the closing date for comments and objections was 12 noon on Monday 13 December 2021.
- 1.5 As a result of the statutory consultation, 63 comments were received. 12 of these were in objection to the proposal.

### 2.1 Results of Consultation

2.1 The objections raised in the comments can be summarised as follows (some responses included more than one comment):



### Background

The Traffic Management Act (TMA) 2004 introduced civil enforcement of traffic offences in England and Wales.

Part 6 of the Act allows councils outside of London to enforce moving traffic offences, making banned turns, exceeding weight limits, and stopping in yellow box junctions.

Despite the 2004 Act now being 18 years old, secondary legislation has never been introduced to parliament and moving traffic offences can only be enforced by the police under criminal law. New legislation has now been laid before parliament and is due to come into force from 1<sup>st</sup> June 2022.

The Government announced their intention to enact Part 6 of the 2004 Traffic Management Act in the "Gear Change: A bold vision for walking and cycling" strategy. The Department for Transport (DfT) is allowing applications to be submitted by Local Highway Authorities for the first tranche until 20<sup>th</sup> May 2022 and following approval will lay the 1st designation orders in parliament during the Summer of 2022. This is all subject to the Parliamentary timetable. Kent County Council (KCC) are on track to apply for these powers during the first tranche. Applications for latter tranches are expected to be invited later in the year.

The DfT have confirmed that the Minster has approved a prescribed list of Traffic Signs (restrictions) and that the powers, when designated, will permit civil enforcement using certified camera devices. These powers do not replace those already held by the Police, who would also be able to carry out enforcement.

### DfT

The DfT announced in September 2020 that they would be fully enacting the remaining elements of Part 6 of the TMA, permitting local authorities outside of London to use approved camera devices to enforce moving traffic contraventions.

By introducing the enforcement of moving traffic contraventions and utilising the latest ANPR camera technology, authorities will be in a far better position to manage and improve their local road network and deliver key objectives outlined in their local transport plans.

### **KCC Proposal**

Implementation and operation of moving traffic enforcement will be managed on a countywide approach undertaken by KCC which will strengthen the Local Highway Authority's statutory duty in meeting the requirements placed upon it under the Traffic Management Act 2004: to reduce traffic congestion in towns and cities and manage the road network.

This will deliver the DfT's requirement for Local Highway Authorities to provide a consistent, controlled enforcement of the highway network, that is in line with the general principles of good regulation. Enforcement under these powers will be carried out in a way which is transparent, accountable, proportionate, and consistent; and will only target locations where action is needed.

As part of the KCC application, a public consultation exercise took place between 15<sup>th</sup> March and 9<sup>th</sup> May 2022 in line with DfT guidance. KCC are now categorising and reviewing all feedback either positive, negative or neutral. Initial indications show support for the Local Highway Authority to take on the enforcement powers. KCC will then consider any objections and identify if there are any

reasonable actions that can be taken to resolve those objections. Following the review of the feedback, KCC will present the findings to KCC's Environment & Transport Committee, with the finalised report to be published on the KCC website.

### Kent Network Benefits of moving traffic enforcement

KCC will use the enforcement of moving traffic contraventions to:

- 1. Improve road safety
- 2. Reduce network congestion
- 3. Increase public transport reliability
- 4. Improve Air Quality
- 5. Increase the lifespan of highway assets

Moving traffic enforcement will only be applied where action is needed to meet one of these objectives.

Responses provided by Mr Valek, Thanet District Manager, KCC

# 1) Details of the KCC budget allowance for dropped kerbs and the process for Parish Councils to liaise with KCC regarding those kerbs no longer fit for purpose.

There is no dedicated budget for pedestrian dropped crossings. Any such requests should be made via our on-line reporting tool at <u>www.kent.gov.uk</u> and are added to our small works list for action as and when funding and resources become available. Alternatively, Parish and Town Councils might choose to submit requests through their Highway Improvement Plans.

### 2) An update regarding the pothole budget for Thanet.

As of 30th May Budget allocation for Thanet Pothole Blitz programme is set at 400k.

# 3) A summary of the communication process between stakeholders regarding the start and finish of road closures for third parties.

Stagecoach, third parties and Stakeholders should be notified of the intent to close a road 56 days prior to works starting, via the TTRO process. The works promoter has the responsibility to communicate to specific parties such as Stagecoach; during their planning phase, if the location is part of a bus route. The Temporary Traffic Restriction Order often contains wording such as, "The scheduled dates may vary for these works with appropriate signage displayed on site", in addition to "the works will be displayed on One.Network".

All parties should assume the dates specified on the TTRO will be the duration of the closure. In some cases works are completed ahead of schedule or delayed due to engineering difficulty. Streetworks will always try to update Stakeholders on road closures with extensions or delays, that is due to the immediate contact made by the works promoter for our assistance.

In the events of a closure being lifted ahead of schedule, rarely that immediate contact is made. Streetworks request promoters to notify Stakeholders of any changes to the schedule, for early or delayed completion. This is very much a condition of the works permit for locations on Lane Rental routes, Traffic Sensitive streets and arterial routes of each district. This page is intentionally left blank
