- · Late Night Refreshment (LNR) shall be between 23:00pm and 23:30pm (internally only). There shall be no LNR served externally. In effect this shall mean LNR can still be served externally until 23:00pm, but not after.
- · Alcohol Provision shall be until 23:00pm externally and 23:30pm internally.

I have also agreed the following condition:

1) During performances of regulated entertainment (both live and recorded) music shall not be audible within any room of any nearby residential premises

- 1, Noted and agreed.
- 2, I used these times as on the licensing form these needed no special licence within the application. As you have noted and seen, v vegan café, any alcohol we are intending on serving would also be strictly vegan, the very last thing we are looking at becoming wou noisy nightspot. We also have planning for a hotel, one part of the planning has been completed and is operational. Music in the co is directly below the two rooms that are active, I very much doubt we would ever consider non acoustic live music outside. We hope the summer months to play recorded music outside, our normal hours are until only 5pm, but we are hoping to run BBQ's in the wa months, again the emphasis would be on more of a chill out vibe. This we hope may extend to our full licenced hours only on occasi during soul weekend in particular but possibly for any other Margate events where there is similar town participation or small (mon private events. We offer an alternative atmosphere to any other Margate venue and would not want to compromise our image, whi would in turn be detrimental to the quality of our hotel guests. The hotel is listed on booking.com as BeetBeds, we have been runr about nine months and have the highest booking.com rating of any Margate hotel. The completed hotel project will add a further t rooms and be Margate's first vegan hotel. I therefore agree to your remarks and recommendations.
