1.0 Introduction and Background

- 1.1 At each ordinary Full Council meeting, the Chairman of the Overview and Scrutiny Panel presents a progress update report on the activities of the Panel since the last Council meeting.
- 1.2 Such a report would be subject to comment or debate by Members. This is in accordance with Council Procedure Rule 15.1 of Part 4 of the Council Constitution.
- 1.3 This report updates Council on the work of the Panel since the last Council meeting and allows for discussion of the work undertaken, therefore strengthening the Council's scrutiny function.
- 1.4 This report follows on from the one presented at Full Council on 05 December 2019.

2.0 Current Scrutiny Activities, including Cabinet Member Presentations

Cabinet Presentations at OSP Meetings for 2019/20

- 2.1 The panel is awaiting cabinet presentations on the following topics:

1. The future management of council housing stock. The presentation would concentrate on providing an update on the preferred option to bring council housing stock into council management (20 February 2020);
 2. Service review of Operational Services (21 April 2020).
- 2.2 The rest of the work programme for 2019/20 is detailed in Annex 1 to the Council report. This schedule is subject to amendments during the course of the year as Members may add more items for reviewing.
- 2.3 Members may also wish to reflect and comment on the content in Annex 2 which provides an opportunity to review and keep track of the spread of the scrutiny review work, particularly between pre and post decision scrutiny activities..

3.0 Panel Recommendations to Cabinet - Implementation Monitoring

Fees and Charges review

- 3.1 The seven member fees and charges cabinet advisory group met on 10 October, ahead of the Panel and Cabinet meetings to consider the fees and charges for 2020/21. Their work kick started the review of fees and charges for 2020/21.
- 3.2 The advisory group focused on car park fees and charges. The proposals for 2020/21 fees and charges were then presented to the Overview & Scrutiny Panel on 22 October. Members made the following recommendation, that:

- Cabinet considered not to increase the events application fee, thereby keeping it at £75.

- 3.3 Cabinet agreed to the Panel recommendation and this had been factored into the council budget reports that was considered by Cabinet and OSP on 14 January and 21 January 2020, respectively. Cabinet then met again on 28 January to recommend the budget proposals for consideration by Full Council on 06 February. Council agreed the Cabinet budget recommendations.

Proposal for the disposal of the Dreamland freehold

- 3.4 Cabinet agreed to negotiate with Sands Heritage Ltd for a housing restriction period of more than 10 years to be part of the agreement of sale.

Adoption of a new Housing Assistance Policy

- 3.5 At the July meeting, the Panel considered a report on the "Adoption of a new Housing Assistance Policy" and recommended to Cabinet that Council writes to Kent County Council requesting that "KCC ring fenced the £405k (Top sliced/payment to KCC projected for 2019/20) for use by Thanet residents".
- 3.6 Cabinet forwarded the request to KCC via a letter sent to KCC by the Cabinet Member for Housing and Safer Neighbourhoods on 12 August. The Panel is awaiting a response from KCC.

Travellers Review Recommendation

- 3.7 After a scrutiny review conducted by a working group, the Panel recommended to Cabinet that "further work be undertaken including extensive public consultation to assess the feasibility and cost implications of establishing temporary tolerated sites in the district."

- 3.8 Having considered the Overview and Scrutiny Panel recommendations on 16 December, Cabinet agreed to the following:

“That further work was undertaken to assess the feasibility and cost implications of three temporary tolerated sites in the District, at Potten Street, St Nicholas at Wade, Tivoli Brooks and Ramsgate Port, with a view to using them on a rotational basis.

Council Budget Setting 2020/21

- 3.9 Members reviewed the 2020/21 Council budget proposals forwarded to the Panel by Cabinet and engaged the Cabinet Member for financial Services in discussion at the January meeting.
- 3.10 After some debate, Members made the following recommendation to Cabinet to consider before submitting the budget proposals to Full Council for final decision:

“that Cabinet considers identifying a resource to support coastal projects.”

- 3.11 Cabinet supported the Panel recommendation, subject to availability of funding. Full Council approved the proposal on 6 February.
