a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The premises were previously used under the trade name Milos as a cafe bar/ restaurant. Mr Hicks is the proprietor of premises next door, number 16. The premises are to be run in tandem along much the same lines. The hours sought are the same as at number 16, together with a share of The Piazza opposite. Food will be available as a bistro style menu.

## b) The prevention of crime and disorder

The premises are covered by CCTV. The bar is situated in the top right hand corner of the premises (as shown on the plan), giving adequate supervision over the whole of the interior of the premises. The premises are being run in tandem with the premises next door, number 16. The DPS will be keeping a close eye on both premises and also ensuring that his staff are fully trained and aware of the need to prevent crime and disorder.

#### c) Public safety

The usual risk assessments for food hygiene, health and safety and fire safety will be in place. The adjoining premises, number 16, has a food hygience risk assessment, together with health & Safety risk assessments. The premises also has a fire safety risk assessment and plan, which will be applied to the next door premises at number 15

#### d) The prevention of public nuisance

The premises are relatively small and run in tandem with number 16, next door., The application is to licence the whole of The Piazza but only that slice opposite the premises will be used (see letter attached). The outside area on the pavement and on The Piazza will only be used during element weather. It is anticipated that in the summer months, both outside areas would cease operations dictated by weather conditions and light. It is suggested that these measures will obviate any possible nuisance

# e) The protection of children from harm
