Dear Cllr Savage

As part of the process to wind up the operations of EKH in an orderly manner, it is necessary to write-off loans that were made to EKH. The outstanding balance on these loans total £278,000 and were made to EKH for the single housing system. The Leader has this morning approved this decision, as you can see from the email trail.

This decision has been taken under urgency provisions as it has been necessary to co-ordinate these activities with the other three Councils involved. Therefore I am writing to you to seek your authority to wave call-in on this matter.

I would be grateful if you could please consider this as soon as possible, as it is intended that all four councils will publish this decision today, Friday 11 September.
